## Our charity

We're Breast Cancer Now, the research and support charity. We're the place to turn to for anything and everything to do with breast cancer. However you're experiencing breast cancer, we're here.

#### **Overview of the directorate**

The research, support and influencing directorate is responsible for delivering Breast Cancer Now's work, through our research, our award-winning services and our successful campaigning. It brings together our research portfolio, our support services (including our helpline), our team of nurses, our health and patient information, our public health, inclusion and awareness team, and our work on policy and influencing.

The directorate has a central role in making sure we achieve our vision, that by 2050, all those who develop breast cancer will live, and live well, and this cannot be achieved without the support and guidance of our partners, our supporters and those affected by breast cancer.

Thanks to the work of the directorate, we will provide support for those affected by breast cancer today and hope for the future.

#### Job purpose

This new role is responsible for the management and development of the Here for You's geographical expansion and working with our stakeholders. This includes managing a small team which works to integrate our referral route into NHS Trusts and may include managing additional support officers in future.

We're currently working with over 60 NHS Trusts in England but have ambitious plans to become UK-wide. The post supports the senior manager, personalised referrals, with targeting areas of high deprivation and high breast cancer incident rates. The role involves significant internal and external collaboration and networking to ensure our services are offered to people diagnosed with breast cancer. This will involve contributing to cross-departmental meetings, working with NHS Trusts and cancer alliances and guiding the team to deliver excellent information and support.

## Key tasks and duties

## Team leadership

- To be responsible for managing support officers and planning clear, task orientated work plans.
- Act as the first point of contact for safeguarding concerns and complaint escalation for the delivery team.
- Create a positive working environment, with a strength-based approach.
- Implement regular evaluation processes to ensure high quality standards are monitored and maintained and as agreed with the senior manager, personalised referrals.
- Lead on the monthly data report in collaboration with the senior manager.
- Collaborate with and sign up NHS Trusts and hospitals to Here for You.
- Liaise with other teams regarding data protection impact assessments.

## Wider Here for You related duties

- Work with the senior manager, personalised referrals, the team leader, Here for You (delivery) and support officers (geographies) to ensure Here for You's growth is sustainable.
- Effectively communicate with the wider team to ensure capacity between the geographies and delivery teams in the personalised referral route.
- Review and innovate the ways we approach and work with healthcare providers to maximise our geographical reach.
- Contribute to the Here for You lived experience project group.
- Review and update the Welcome Packs for newly signed up NHS Trusts.

## Platform management and databases

- Work with our CRM team and address any concerns.
- Ensure the customer record management databases are kept up to date.

## Working across services and teams

- Work with the primary and secondary services teams to proactively seek opportunities to collaborate and find opportunities to deliver a cohesive offer.
- Work with the service pledge team and integrate Here for You into the cancer alliances they work with.
- Work with the legal and safeguarding team to ensure we're GDPR compliant.
- Work with the marketing team to ensure our promotional materials are up to date.

- Be an effective and proactive member of the services team and the wider charity, working collaboratively and productively with colleagues.
